6. Accidental release measures

Procedures for cleaning up spills or leaks

7. Handling and storage

Precautions for safe handling

Observe label precautions. Close container after each use. Do not transfer contents to unlabeled containers. Wash thoroughly after handling and before eating or smoking. Precautions should be taken to prevent the formation of dusts in concentrations above flammable, explosive or occupational exposure limits. Keep away from open flames, hot surfaces and sources of ignition. Electrical equipment and lighting should be protected to appropriate standards to prevent dust coming into contact with hot surfaces, sparks or other ignition sources. If material is a coating: do not sand, flame cut, braze or weld dry coating without a NIOSH approved air purifying respirator with particulate filters or appropriate ventilation, and gloves.
